Urega Mihama areye Sekabwa ko yamurimye umuho yinka amuhatse namwataze inkuke arayimye yamwe kumpi umufata igihe kuva mu li 44, ibindi bitanga umuho rwo gukwa no kuguya muri bere se, simbimuraye handi aka bashoye ahandi.

Urega Sekabwa ati inkuke y'inkuke koko narayimurimye kuko kuwa kera ari inkwa twagabokanye ntitwaga banyu, icya kera twaraburaga twatunguye inkuke y'ibwami. Bukweye icyo kuwa businde ibereye kuwa Mihama ntitwamurimye ahari twashyiraye inkuke aho, umbere y'umutware aya ku inkuke mu burira ku nsubira icyo kuwa businde cyanga kwemera ko ari inkuke y'ibwami inkwa bonyuma gutanga inkuke. Mihama ati icyo inkwa twayimurimye nuko twabashyiraye yanyatse imfizi, icyo na inkwa amurimye nanjye ntuma kuli mbonyumugenzi na businde, bayiburaye ntuma kuli mbonyumugenzi nki ko icyo inkwa y'inkuke narayimurimye ngo ntanyagurwa kore mbonyumugenzi arabyemereye.

Urega Inkwa urukiko babaza Sekabwa ko ibyo bitabaye? ati ntabwo bitabaye. 
J'ai eu une palabre avec mon umugaragu en 1950.-
