et MUVUGA.-


Monsieur le District Commissioner,



There are two Banyaruanda at present
in Kabale Hospital who have been transferred here
as they were found destitute in Kampala.

2. Their names and particulars are as
under:-

(1) Balyambona s/o Lugina
Kaguhu District,
village, Kaguhu,
Chief, Serudida
Ruanda urundi. Ruhengeri.

This man is paralysed on one side of his body.

(2) Muvuga s/o Ndabogoye,
Matyazo District,
Chief Yozefu Nyawakira,
ruanda Urundi, Ruhengeri.

This man is said to be epileptic. He fell in a fire
during a pit and one of his arms has had to be
amputated.

3. I will arrange to have these men sent to
you when transport is available if you could arrange
to have them sent to their homes.
