GAKWANDI aravuga ati ndibaza igisuma Abajandarume banteye n'ijoro bakansenyera urugo hanyuma bakazara bahondagura urugi rwanje kandi nzi ke nta cyaha msite eyatuma barara bampiga bakansenyera n'uruge.

Q: Wabwiwe n'iki ko ali Abajandarume baguteye?

R: Bahondaguraga amadilishya bavuga ngo kingura tuli Abajandarume, kandi nanje nkingura umwenda w'igidilishya nsanga nibo bafite imbunda, nsubizaho umwenda, ndabihorera, ntegerenza ko bagaza kunshaka habona. Aho bukerewe bigejeje saa tatu ntstabonye, nibwo niyemeje kubimanyesha Konseye. Kuke ibyo ali urugomo ruvanze n'itera bweba, bituruka k'umuturanyi wanje MUNYANTORE dufitanye urubanza namutaindiye rw'amazu twaburanaga.

Q: Ese? mubaturanyi bawe ntawundi munzu waba yabumvise?

R: Ati n'abacumbitse iwanje babyumvise, balimo n'umuboyi wabo witwa SIBOMANA Salemani kuko yabashije no kuvugana nabo bajandarume.

Q: Kuli SIBOMANA Salemani mwene BANGANEZA na MUKAMUKAMA uvuka Komini RUKONDO - GIKONGORO ati: Jyewe nali munzu ntera ipesi numva abantu bakomanze k'umuryango w'irembo ngirange ni badatabuju baje, nkinguye numva abantu bambwiraga ngo ngwine ukingure, ndababwira nti ntamfunguzo msite zaho, batu genda ubwire beneho baze bahakingure, kandi ubabwire ko ali abajandarume babakingura, kandi nanje ubwanje nabarebaga usibye ko ntashoboye gufata isura yabo. Ubwo nabonye bene uruge basinsiliyananje numva msite ubweba msite nsubira munzu ndakinga. Q: Kuli GAKWANDI: nta bandi baturanyi baba babibonye?

R: Ati: Ubwo baba bali bahali usibye ko jye nagize ubwoba minabasha gukingura nge njye hanze.

Q: Kuli GAKWANDI: Hali kindi wongera kuli'ikibazo eyawé?

R: Ati: Ibyo nakengera ku kibazo eyanje, mbere na mbere n'ukwishingana, kuke atalibwo bwambera bantera, no muli 1984 mu kwezi kwa cumi na kumva higaze kuza igitere ey'Abajandarume gituratse ku bakobwa ba MUNYANTORE dufitanye urubanza, abo Abajandarume bali bayobwe n'uwalilier Sgt Major witwa HATUGAKIMANA wali umhinzwe ipererezza muli Brigade ya Nyarugenge, K'uburyo nishinganye mu biro bishinzwe ipererezza muli Présidence ya Republik ya u Rwanda. 
