Dear Sir,

I regret to inform you that the above mentioned man who was an employee of the E.A. Tea Estates, Kiamara Group, Fort Portal, was killed from injuries received from a bullet wound, in a recent disturbance in which he was involved.

The employees of the Estates came out of the strike and eventually rioted. This man was of the riotors and in a disturbance with the Police was wounded and later died in Fort Portal Government Hospital. He has been buried there.


His property and any pay due will be eventually sent to the District Commissioner, Kigezi, and you will be informed.

We would be grateful if you would inform his Chief and his relatives.


